# Methodology



The following are key findings from a **national survey of 832 Gun Owners, (401 NRA gun owners and 431 non-NRA gun owners)** conducted by The Word Doctors on behalf of Mayors Against Illegal Guns on November 25 – December 2, 2009.

The sample is subject to a **margin of error of 3.5%**.



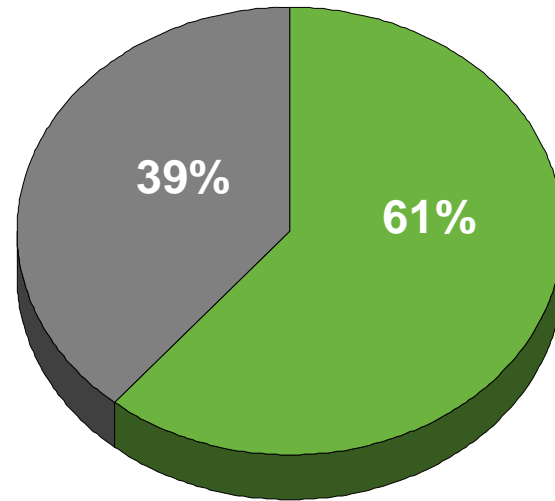

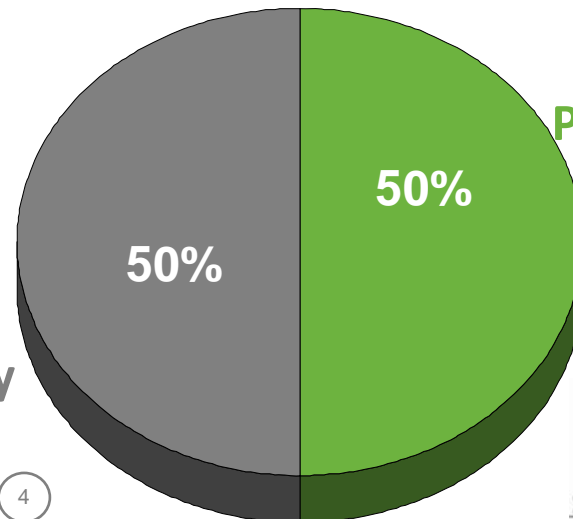

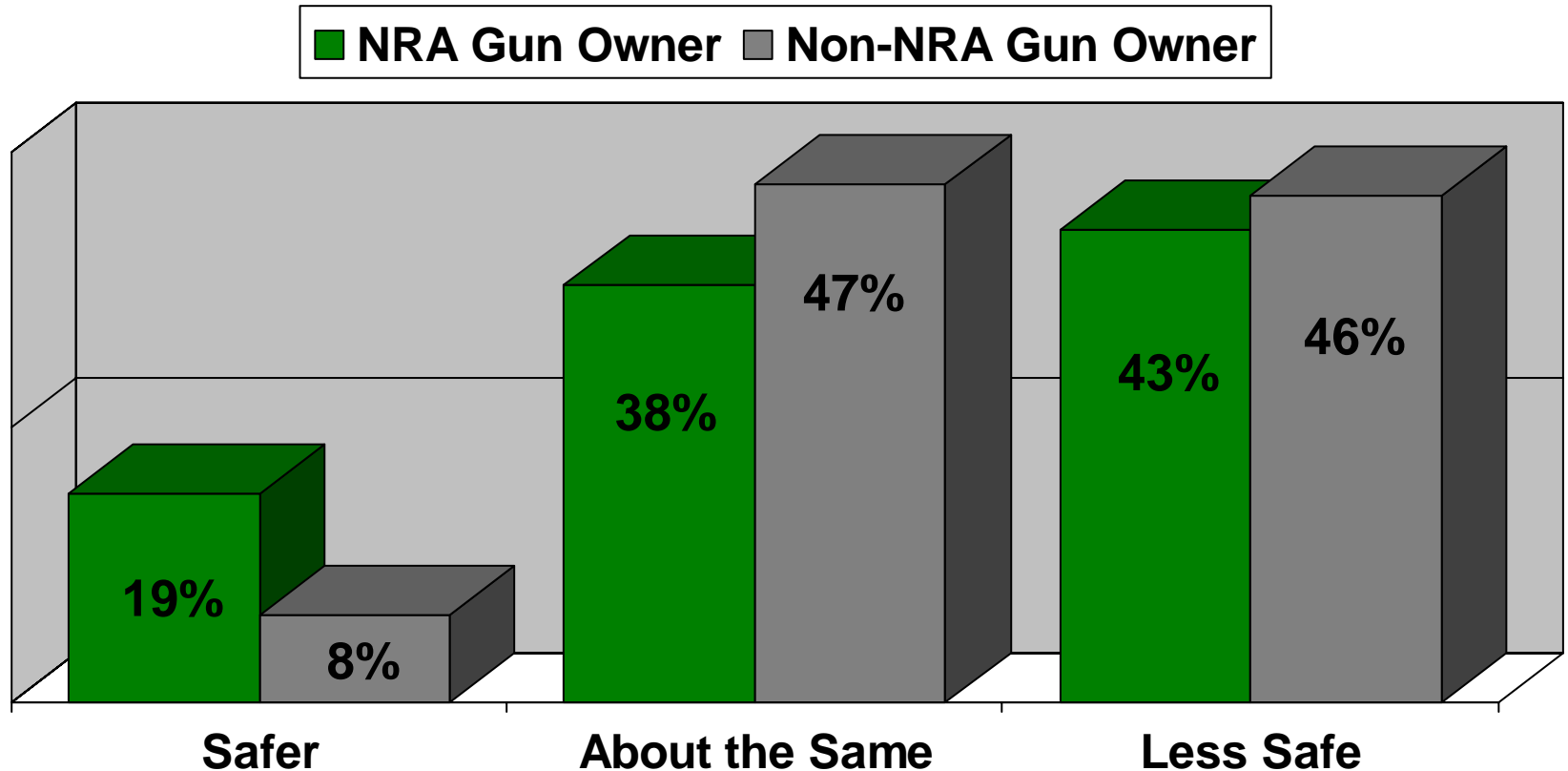

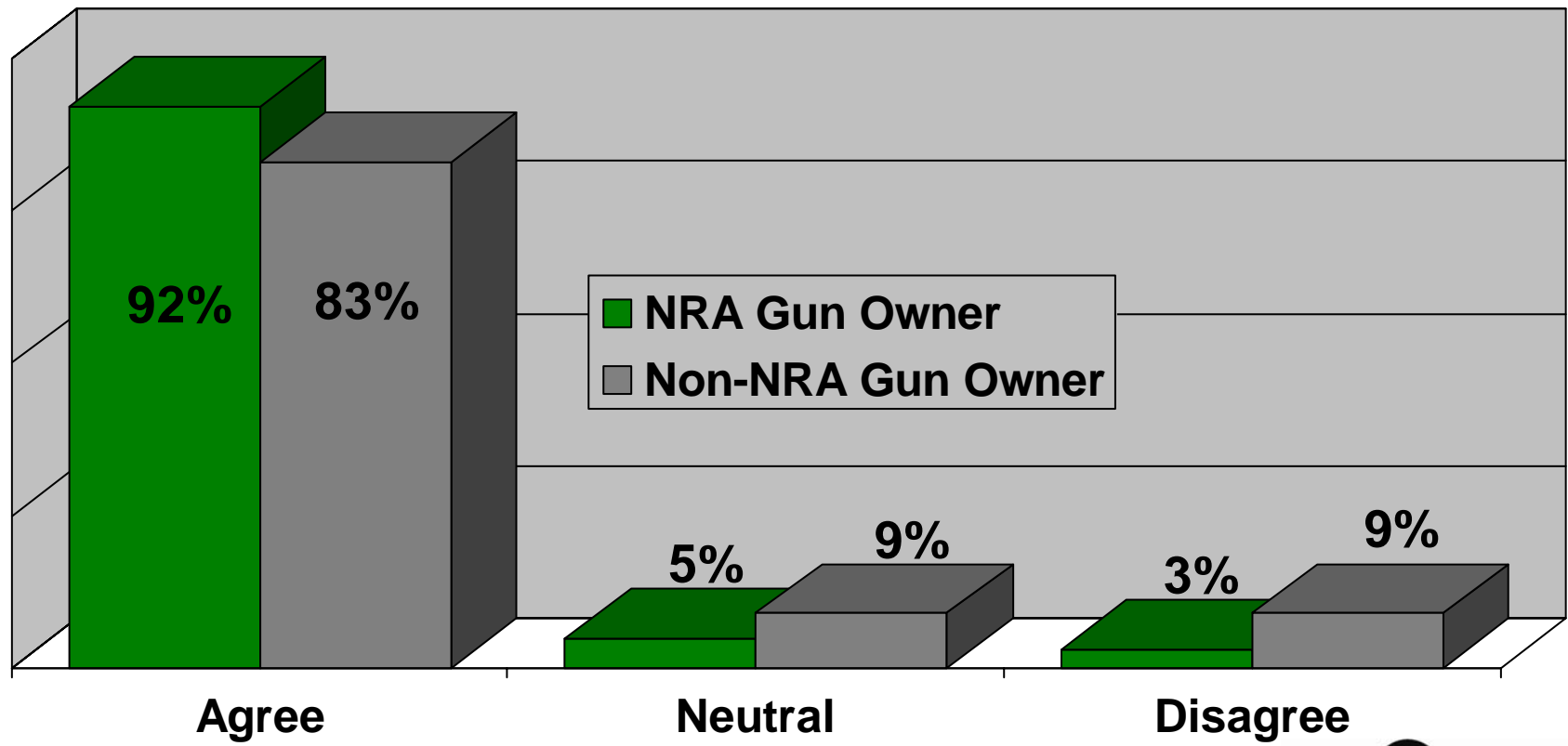

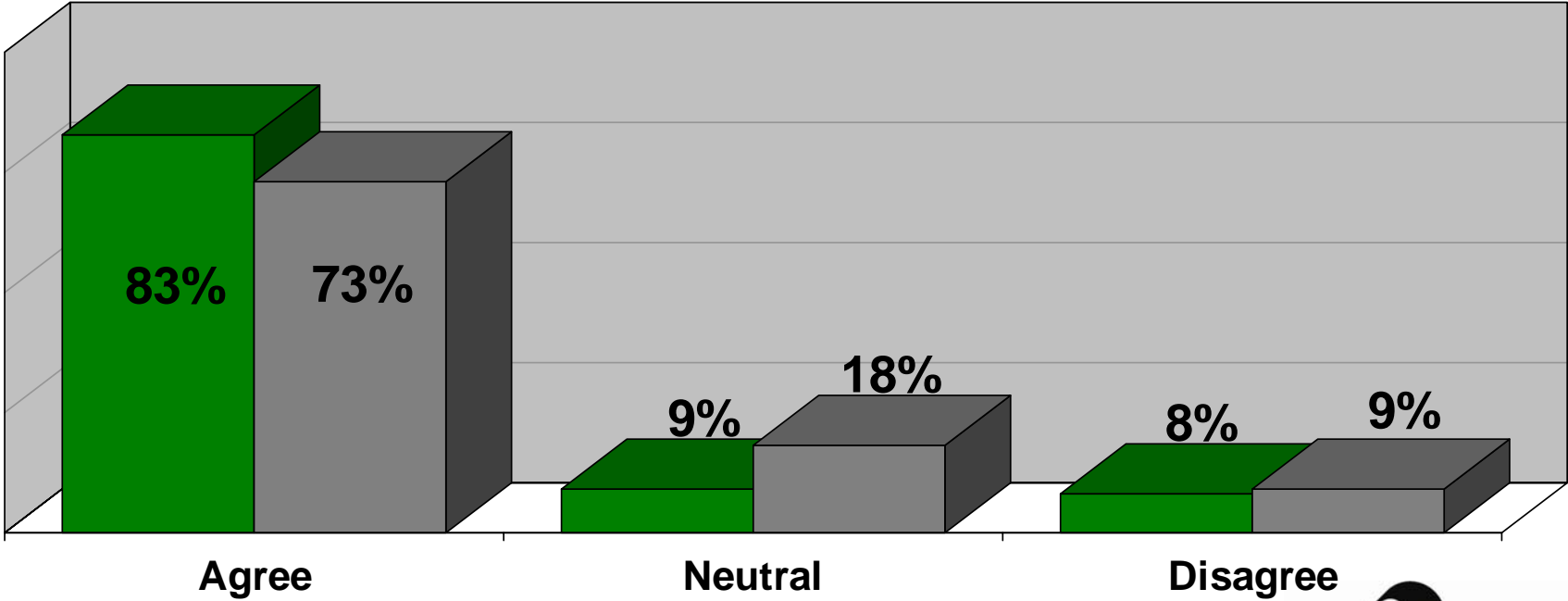

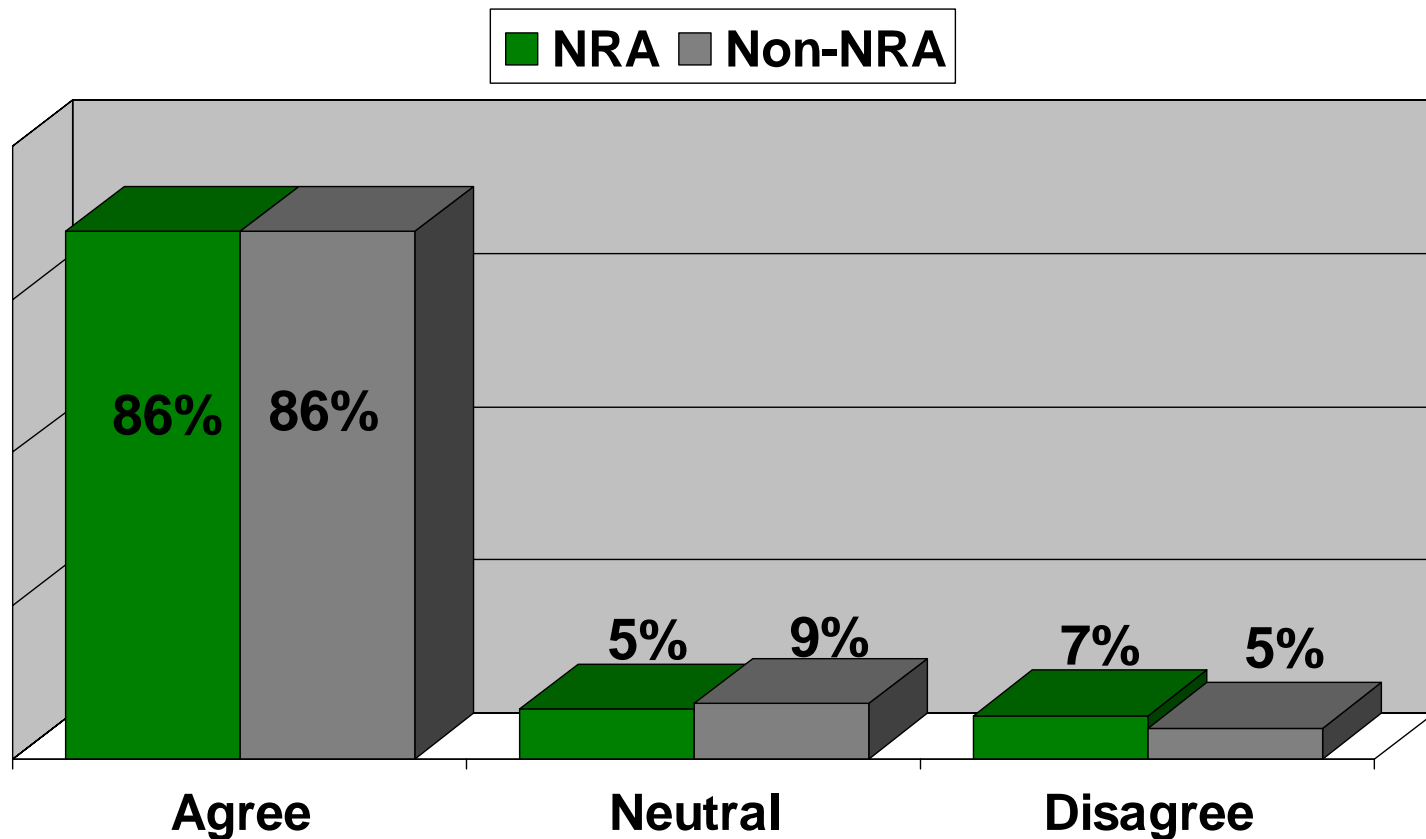

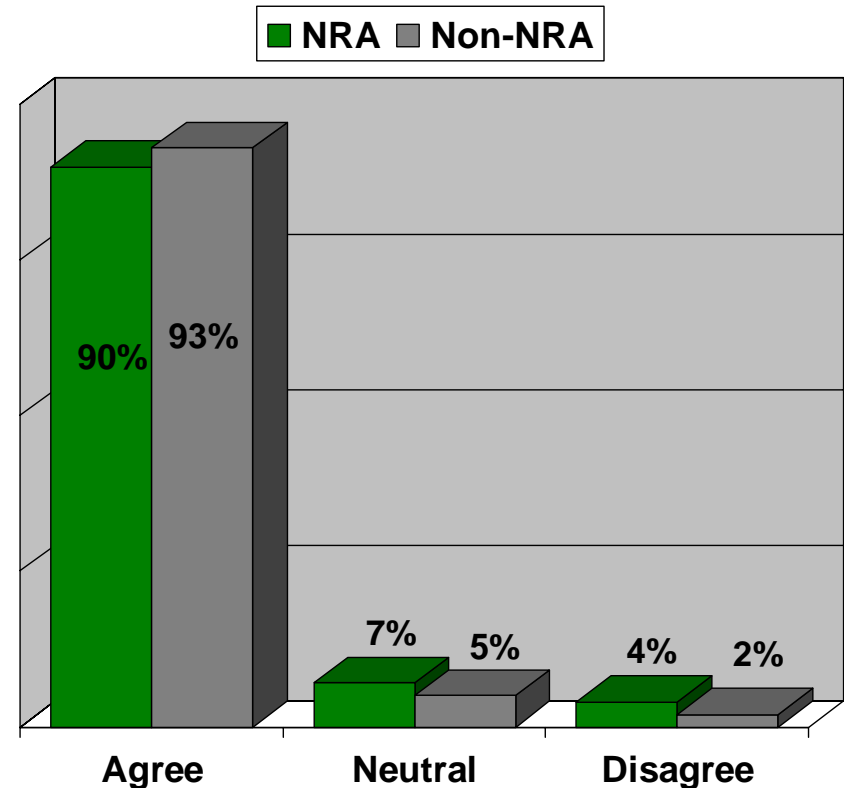

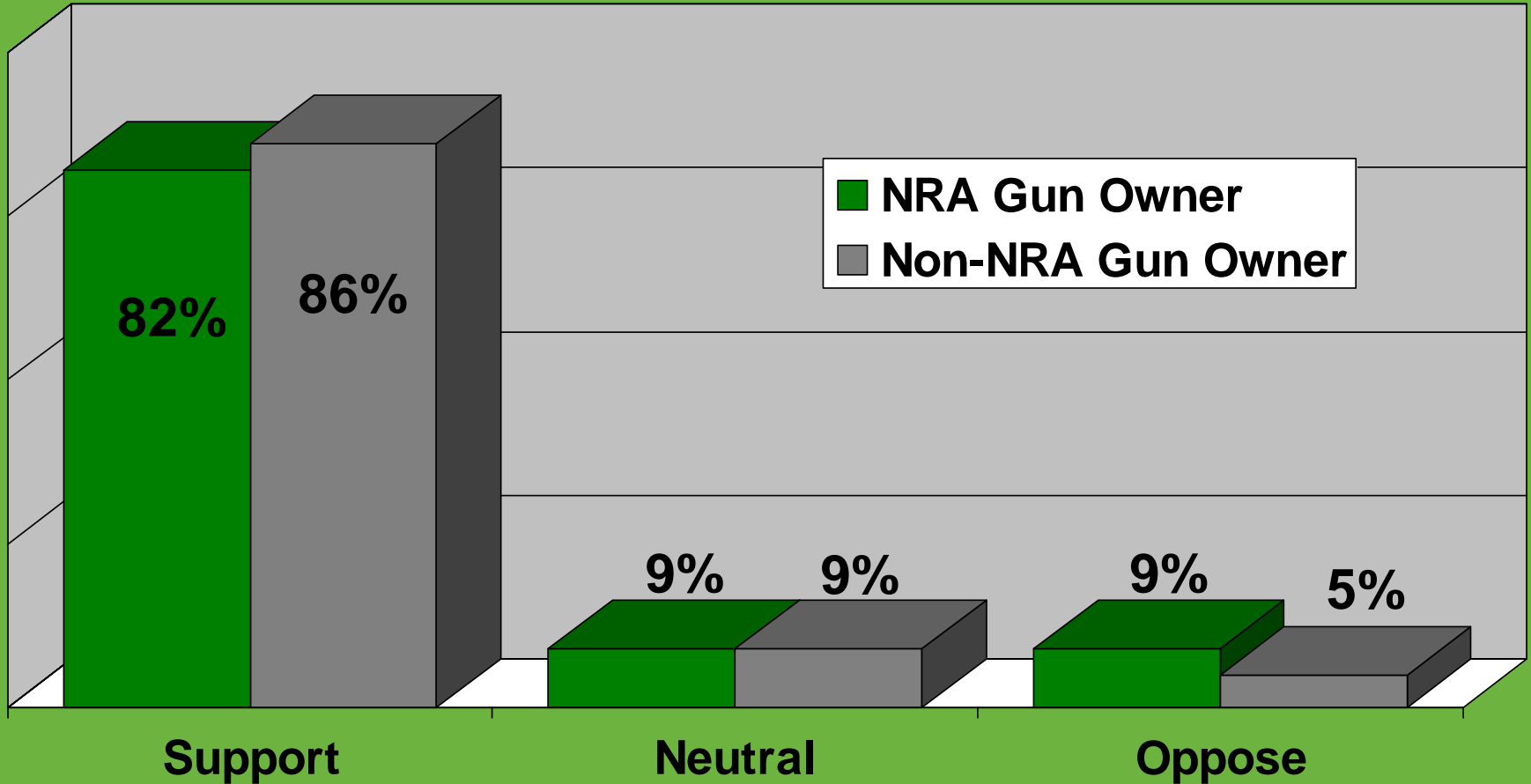

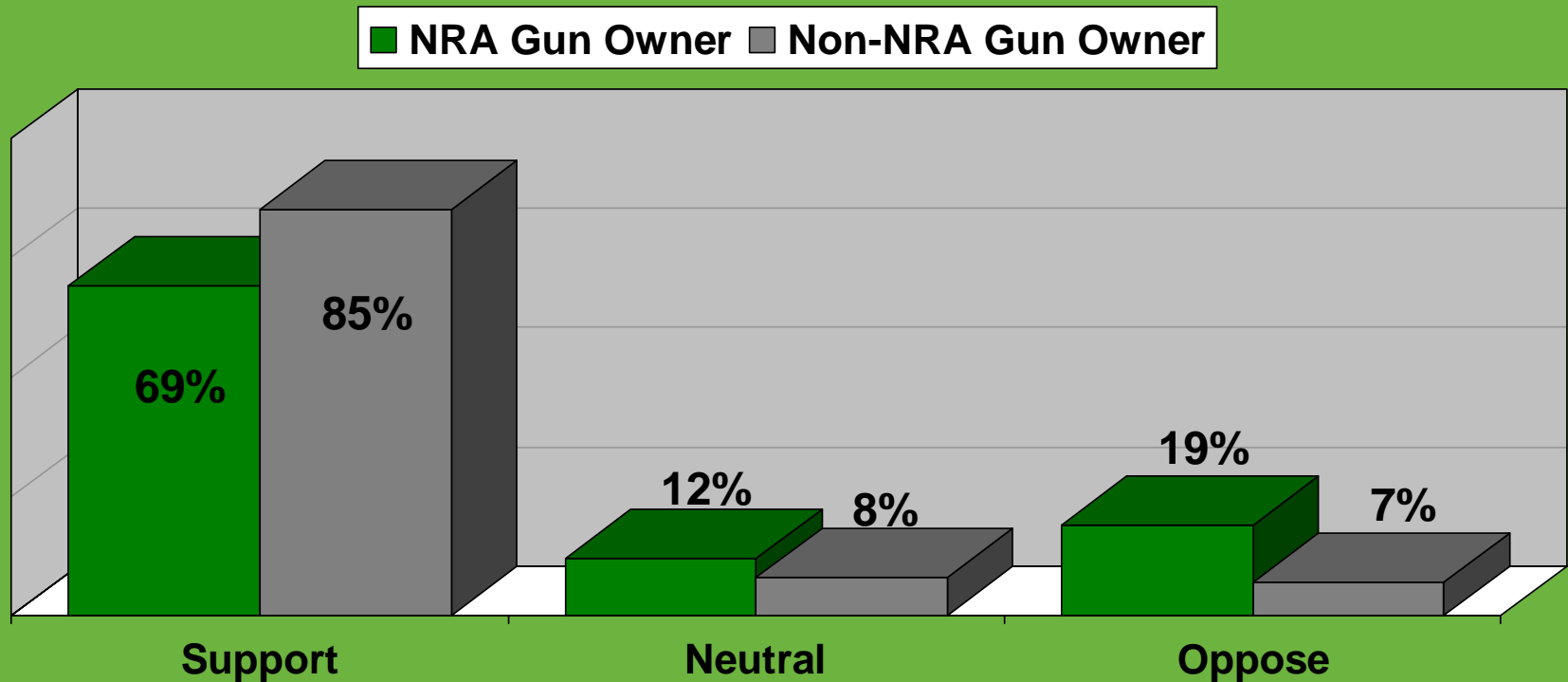

*A proposal requiring all gun sellers at gun shows to conduct criminal background checks of the people buying guns.*



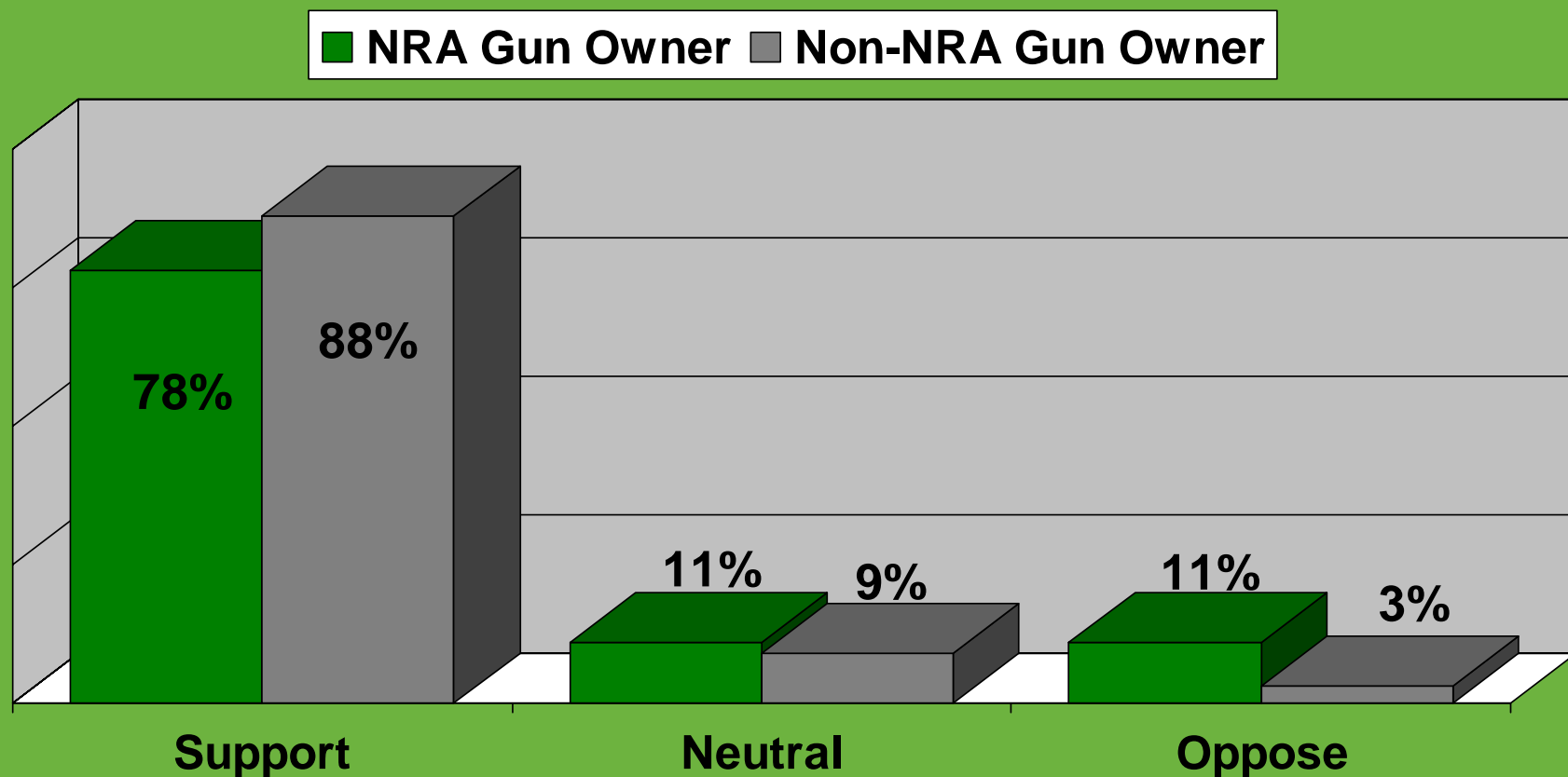

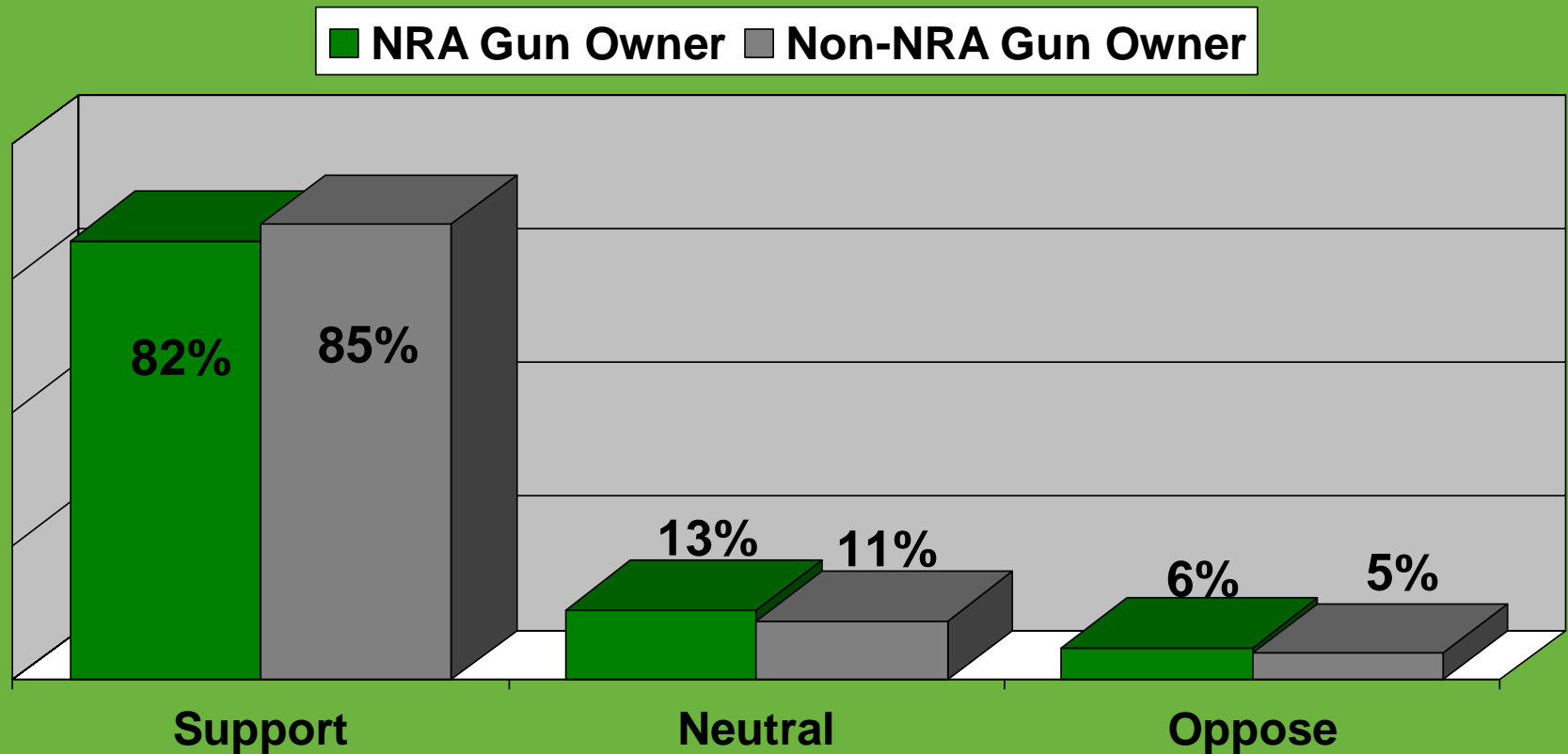

*Do you \_\_\_\_\_ the following?*


*A proposal requiring gun retailers to perform background checks on all employees to ensure they are not felons.*

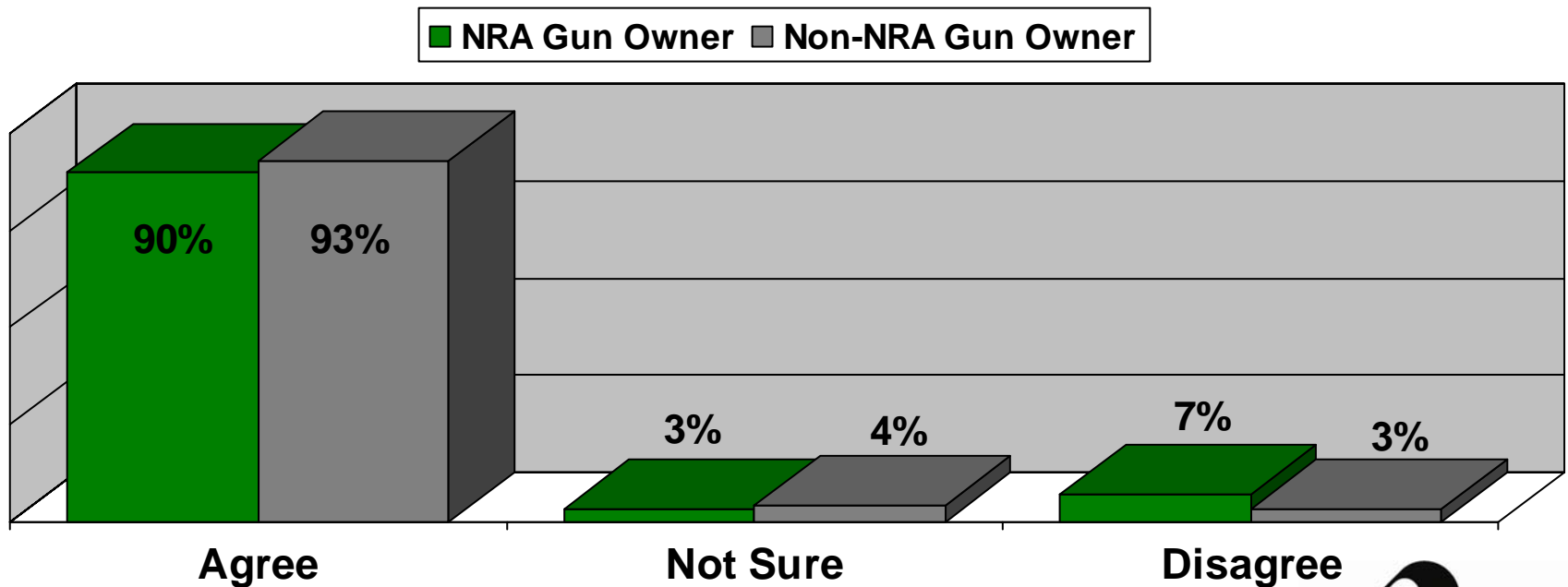

# Connecting the dots on gun purchases by suspected terrorists

*Prior to the Fort Hood shootings, Major Nidal Hasan had been under investigation by the FBI Joint Terrorism Task Force for having at least ten contacts with a radical Muslim cleric with ties to al-Qaeda. With that in mind, do you \_\_\_\_\_ with this statement:  
“The FBI should be able to access and keep information about gun purchases by terror suspects in cases similar to Major Hasan.”*



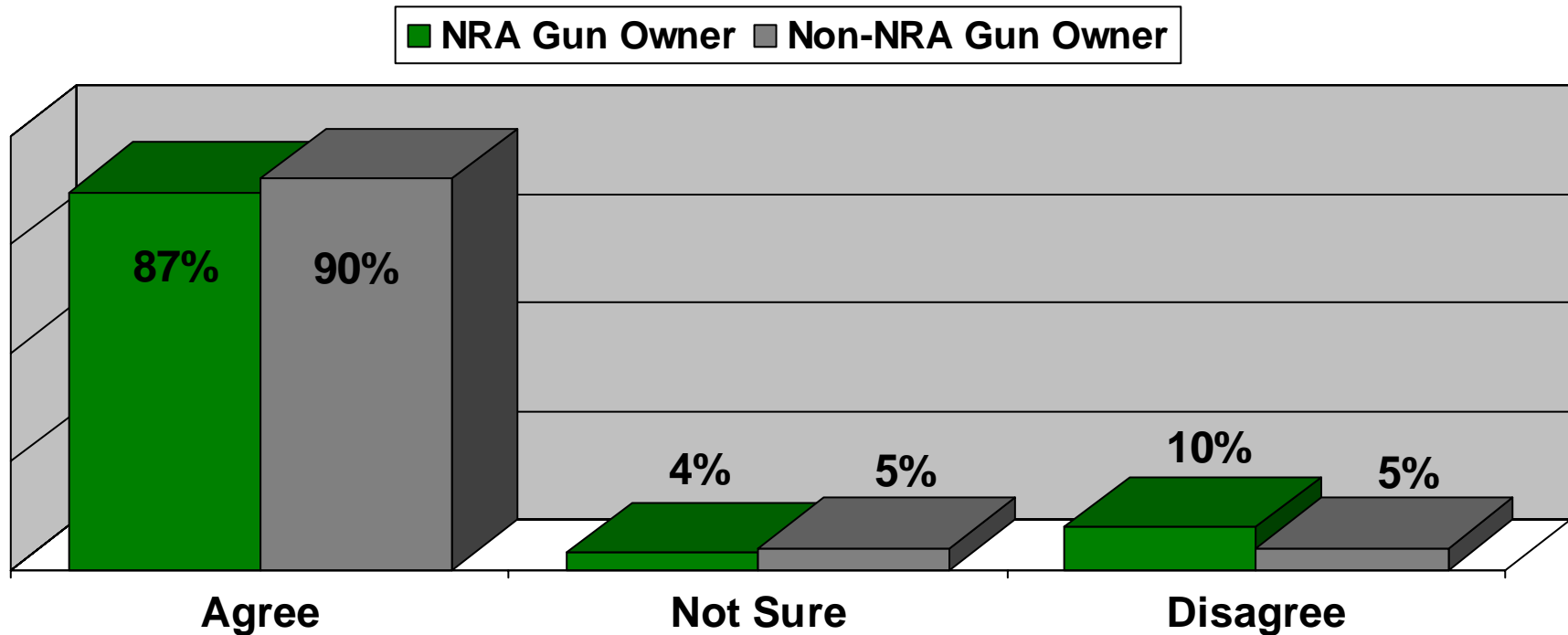

# Blocking gun purchases by suspected terrorists

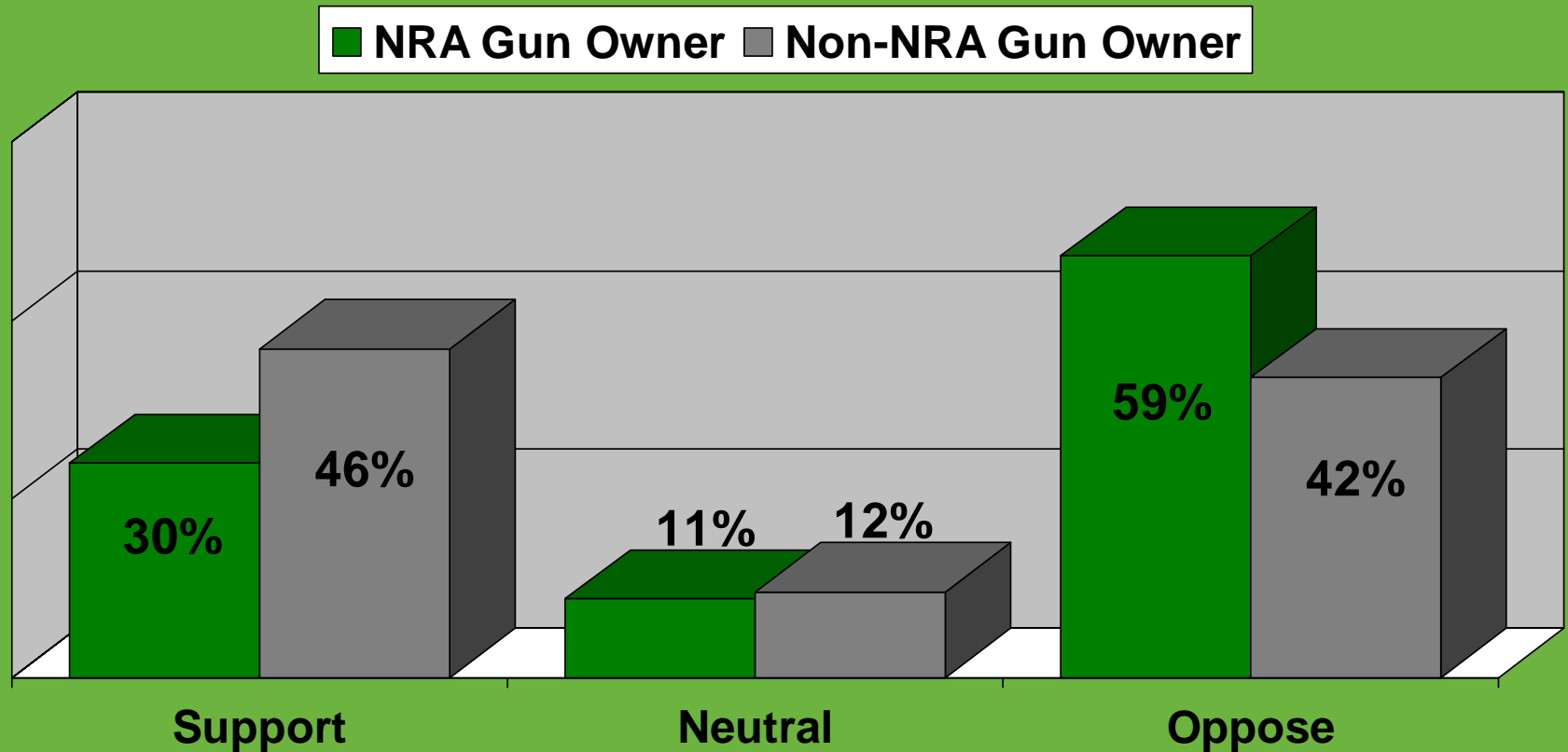

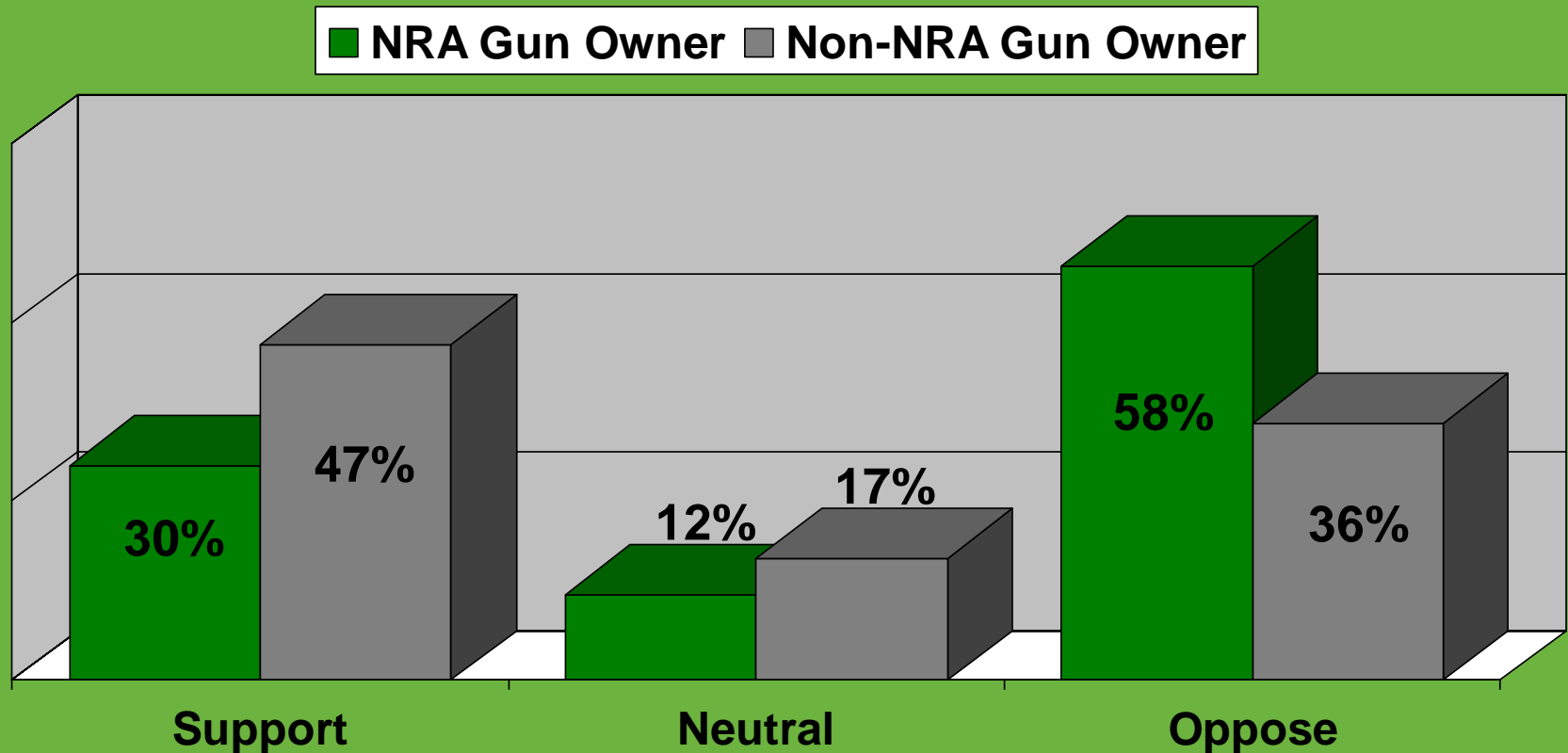

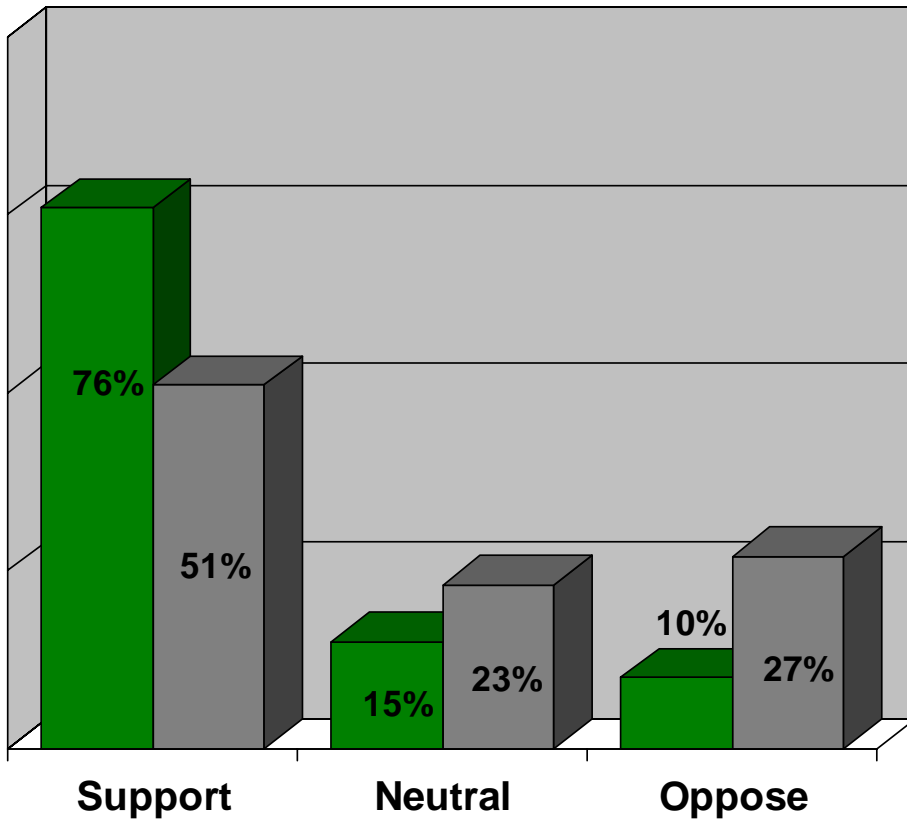

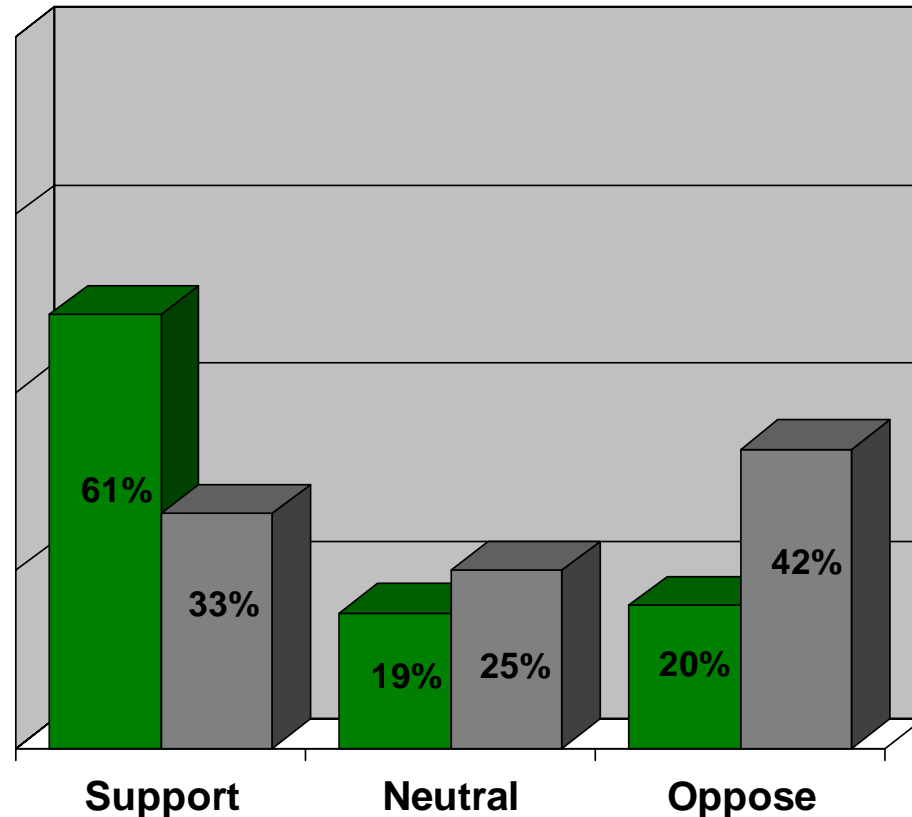

**President Obama has said:**

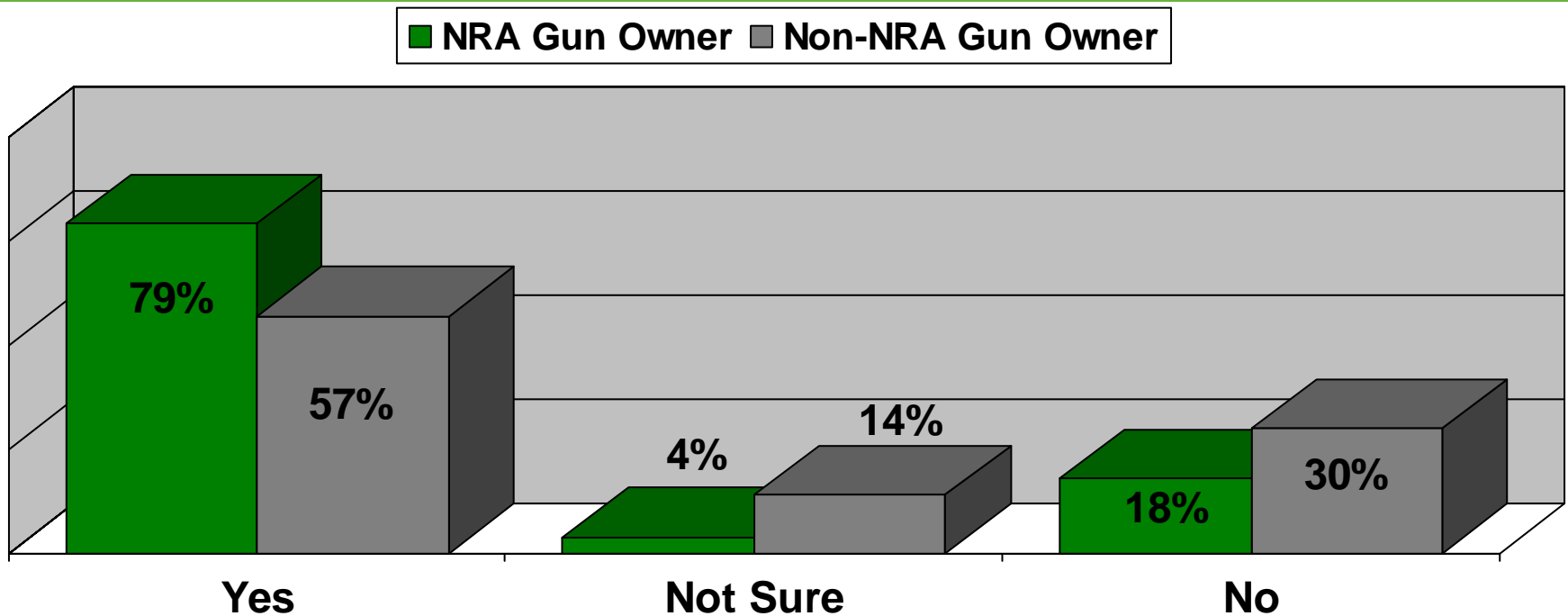
*"I believe in the **Second Amendment**...
